Besides this Member Inspection Team-II of Honourable High Court of Sindh Karachi and Director General, National Accountability Bureau Sindh Karachi were also requested to monitor the said process vide this Inspectorate General letters No.SB-1/13373 & SB-1/13374 dated 27.07.2015 respectively, but they could not attend the meeting.

Accordingly, in response to the advertisement regarding invitation of sealed bids for annual contract for supply of cooked food for the fiscal year 2015-16 to prison inmates invited on 29th July 2015, bidders purchased 172 bid documents for all the prisons in Sindh

within the stipulated period upto 28.07.2015. Prison-wise break-up of the bid documents purchased by the bidders is given here as under:



The procurement of cooked food is being made and regulated in accordance with the Sindh Public Procurement Rules 46(2) Single Stage Two Envelope Procedure, therefore, Technical Proposals were opened and names of bidding firms were announced, 17 bidders submitted 78 bid documents. The Committee evaluated the technical bids at length along thoroughly with all the documents; which are deemed mandatory for qualification of the bidders for supply of dietary articles (cooked food) to the inmates of the Prisons for the year 2015-16. Evaluation was based on following criteria.

- (i) Personal Capabilities,
- (ii) Catering Experience,
- (iii) Equipments Capabilities,
- (iv) Financial Soundness,
- (v) Registration with Sales Tax & Income Tax .
- (vi) Signature of bidder on each page of bid document

(vii) Affidavit on stamp papers about blacklisting

Accordingly, 17 bidders submitted with bid documents for following 21 prisons whose bids have been evaluated according to assigned criteria as provided in bid document. Findings regarding bidders are given below.

1. **M/S ABDULLAH & BROTHERS:**

Has submitted technical proposals in respect of Central Prison Karachi, District Prison Malir Karachi, Y.O.I.S & Women Prison Karachi, Central Prison Sukkur and District Prison Sukkur. He has furnished requisite documents complete in all respect, therefore, has been qualified in technical evaluation rendering him successful for opening his financial proposals.

2. **M/S COSMOS ENTERPRISES:**

Has submitted technical proposals in respect of Central Prison Karachi, District Prison Malir Karachi, Y.O.I.S & Women Prison Karachi, Central Prison Hyderabad, Y.O.I.S Hyderabad, Special Prison Women Hyderabad, District Prison Dadu. He has submitted all the requisite documents, therefore, has been qualified in technical evaluation rendering him successful for opening his financial proposals.

Has submitted technical proposals in respect of Central Prison Khairpur, Central Prison Larkana and Special Prison for Women Larkana. He has submitted all the relevant documents, therefore, has been qualified in technical evaluation rendering him successful for opening his financial proposals.

14. M/S ZUBAIR HYDER KHOKHAR:

Has submitted technical proposals in respect of District Prison Nausheroferoze, District Prison Shaheed Benazirabad and Special Prison for Women Larkana. He has submitted all the relevant documents, therefore, has been qualified in technical evaluation rendering him successful for opening his financial proposals.

15. M/S BUSINESS LINKS & TRADE:

Has submitted technical proposals in respect of District Prison Sukkur only. He has submitted all the relevant documents, therefore, has been qualified in technical evaluation rendering him successful for opening his financial proposals.

16. M/S MOHAMMAD SIDDIQUE KHOKHAR:

Has submitted technical proposals in respect of District Prison S.B.abad and District Prison Nausheroferoze. He has submitted relevant documents to some extent for keeping the competition wide open, the Committee has discussed in detail, therefore, has been qualified in technical evaluation rendering him successful for opening his financial proposals.

17. M/S CAMBRIAN ENTERPRISES:


Has submitted technical proposals in respect of Central Prison Hyderabad, District Prison S.B.abad and District Prison Nausheroferoze. According to the terms & condition of the bid document he is not found eligible to submit his bid (proposal) for Central Prison Hyderabad falling in Zone-A prisons.
