As per NIT, first opening was scheduled on 13-6-2016, but not a single bid was received till deadline, therefore, the option of second opening of bids / tenders was availed as mentioned in the original NIT published in Daily Jang dated 26-5-2016, Daily Kawish dated 29-5-2016 and the Express Tribune dated 29-5-2016 vide Information Department reference No. INF/KRY. No. 2382/16. Simultaneously, NIT was also hoisted on SPPRA website on 01-6-2016 at serial No. 29314. Notice for 2nd date i.e 28-6-2016 was also published in the Newspaper Daily Kawish dated 18-6-2016, Daily Jang and Express Tribune dated 19-6-2016 vide No. INF/KRY. No. 2600/2016 and intimation given to SPPRA vide letter No.SO/SKA&SDD/4-39/2016/240, dated 16-6-2016.
- 3. The Sealed Box was opened in the presence of all members of the Committee and the representative of the bidder. Only one bid document was issued / sold to Mr. Muhammad Masood Khan, whose only bid was received till deadline i.e 28-6-2016 @ 3:00 pm as no any other party responded to the advertisement so published.
- 4. The sealed bid was opened by the Procurement Committee in the presence of bidder's representative Agha Abdul Qadeer. The financial proposal was seen / signed by the members of the Committee. It was found that the sole bidder had provided the requisite documents as per NIT.

- The sole offer received from Mr. Muhammad Masood Khan for a 1000 sq. yds. bungalow situated in P.E.C.H.S, near Kashmir road at rent of Rs. 525,000/- per month (inclusive of all taxes). The bidder in his offer has added some terms / conditions including payment of security deposit equivalent to 4 months rent.
- The Committee also decided to visit the offered premises to see its physical condition and location. During visit, it was found that offered house was well constructed and in a good condition with spacious rooms to be used as committee room / conference hall and ample space for car parking available.
