Bidders submitted their bids on 13.07.2016 upto 11:30 a.m. Tender Box, containing the bid documents duly sealed was kept before the Procurement Committee on the same day at 12.30 p.m which was opened publically in presence of the bidders who were present on the occasion. The procurement of cooked food is being made and regulated in accordance with the Sindh Public Procurement Rules 46(2) Single Stage Two Envelope Procedure, therefore technical proposals were opened and names of bidding firms were announced, 19 bidders submitted 85 bid documents for different prisons as well as sealed envelopes of financial proposals of the said bidders were again put in the tender box and sealed the same accordingly.

The Committee evaluated the technical bids according to evaluation criteria mentioned in the bid documents thoroughly with all the documents which are deemed mandatory for qualification of the bidders for supply of dietary articles (cooked food) to the inmates of the prisons for the year 2016-2017. Evaluation was based on following criteria.

- (i) Personal Capability,
- (ii) Catering Experience,
- (iii) Equipment Capabilities,



- (iv) Financial Soundness i.e. Bank Statement alongwith details of Income Tax deduction of last three years (2013-14, 2014-15, 2015-16).
- (v) Registration with Sales Tax and Professional Tax Certificate.
- (vi) Signature of bidder on each page of bid document.
- (vii) Affidavit on stamp papers to the effect that the firm is not blacklisted.

Accordingly, 19 bidders submitted bid documents for 21 prisons whose bids have been evaluated according to the prescribed criteria as provided in the bid document. Firm-wise findings are narrated below.

**1. M/S CHOUDHARY ALI MOHAMMAD & CO.**

This firm has submitted technical proposals in respect of Central Prison Karachi, District Prison Malir Karachi. The firm has furnished requisite documents complete in all respect, therefore, has been qualified in technical evaluation rendering him successful for opening his financial proposals.

7/- Meeting ended with the vote of thanks by the Chair.


