

SUBJECT: MINUTES OF THE CONSULTANT SELECTION COMMITTEE HELD ON 12-04-2017 TO EVALUATE TECHNICAL PROPOSAL RECEIVED UNDER ADP SCHEME "PREPARATION OF SINDH GDP" (ADP SR NO: 1727/2016-17).

Meeting of the Consultant Selection Committee (CSC) was held on 12-04-2017 at 11:30 a.m. under the chairpersonship of Director General, Bureau of Statistics, Planning & Development Department, Government of Sindh. The agenda of the meeting was to evaluate the Technical Proposal received under ADP scheme "Preparation of Sindh GDP" for estimation of Provincial Gross Domestic Product (GDP).

2. The chair welcomed the members of CSC and inquired about the presence of all members of CSC, in response Mr. Kazim Jafri, Deputy Director (BOS) read clause 68 of SPP Rules 2010 to underline the completion of Quorum. Then chair asked Mr. Muhammad Nasir Khan, Statistical Officer (GDP) to recapitulate the progress so far achieved for selection of consultant. The incumbent narrated that Planning & Development Department issued CSC notification dated 22-12-2017 thereafter; CSC finalized the Expression of Interest (EOI) and Request for Proposal (RFP) in its meeting held on 26-12-2016. Subsequently, EOI was published in leading newspaper on 16-01-2017 and two extensions were accorded on premise that no firm submitted proposal. Further, it was elaborated by Statistical Officer (GDP) that considering this assignment as highly complex and innovative the CSC decided to select consultancy firm on Quality Based Selection Method as prescribed under rule 72 (2) of SPP Rule-2010 (Amended 2013). While the evaluation criteria is based on 20% weight-age to companies profile and 80% weight-age to consultancy team.

3. Further, Statistical Officer (GDP) informed the members that only single proposal from M/s SABCON (Pvt) Ltd have been revised. The chair asked whether single proposal can be entertained for evaluation as per SPPRA Rules. In reply Mr. Kazim Jafri, Deputy Director (BOS) quoted clause 48 of SPPRA rules which revealed that single bid can be processed on condition that prices are comparable to the price of the last awarded contract or market price. Taking part

in discussion, Statistical Officer (GDP) pointed that procuring agency has prerogative to negotiate on financial proposal under Quality Based Selection Method clause 72(2)(c) of SPPRA Rule.

4. The committee than initiated that process of evaluation of Technical Proposal by scrutinizing the eligibility criteria as described in RFP. The CSC found that the consultancy firm is eligible as they are active tax payers, registered with Sindh Revenue Board (SRB) and has submitted affidavit of not been blacklisted by any institution/department/agency.

5. The chair than asked the members to technically evaluate the proposal as per evaluation parameters one by one. At one point the chair asked whether Ph.D dissertation of Dr. Kaiser Bengali is corresponding to preparation of National/ Regional Accounts. Dr. Fateh Marri, Project Coordinator (WISP), Co-opt Member volunteered to evaluate the Curriculum Viate of Dr. Kaiser Bengali and found following assignments/consultancies conducted by Dr. Kaiser are associated with preparation of National/ Regional Account that is, (1) Regional Accounts of Pakistan (1991-1995), for the World Bank, Islamabad (1997). (2) Provincial Accounts of Pakistan: Methodology and Estimation, 1973-2000, Social Policy & Development Centre (2005) (3) Issues in Green Accounting in Pakistan, Lanka International Forum on Environment and Sustainable Development, Colombo, Sri Lanka (1996).

6. After detail evaluation of technical proposal, M/s SEBCON (Pvt) Ltd was awarded 74 marks out of 100 max marks which was way above from threshold of 60%. Therefore, committee cleared the technical proposal and decided to approach M/s SEBCON (Pvt) Ltd to submit its financial proposal for this assignment. Dr. Qazi Masood Ahmed, Co-opt member highlighted that financial proposal must explicitly mention the amount of financial resources would be needed by firm to obtained primary data.

Decisions:

1. The Consultant Selection Committee (CSC) cleared the technical proposal of M/s SEBCOM.
2. The committee decided to approach M/s SEBCOM to furnish financial proposal in accordance rule 72(2)(c) of SPPRA Rules (2010).
