- 4). After deliberations the Procurement Committee recommended opening of financial bids of the above (03) three firms. No any representatives of firms were present in the said process.

- 7). Committee recommended that successful bidder shall visit <sup>arrange a</sup> his Workshop to JPMC Authorities.
- 8). The Committee recommended and approved the bid amounting to Rs.496,500/- (Rupees Four Hundred Ninety Six Thousands & Five Hundred Only) of M/s:Hadi Enterprises, being the lowest.
- 9). The meeting ended with vote of thanks to and from the Chair to the participants.






