- The committee recommends M/s Shahzad Traders as successful bidder being lowest quoted bids for supply of office equipment and ancillary services under the project "Electrification of Primary Health Facilities through Solar PV Technology".
- ii. The Committee also observed that the quoted price of M/s Shahzad Traders for Android Based Smart Phones is much higher than open market prices. Hence, the Committee recommends procuring the Smart phones from open market through "Request for Quotation" procedure and rest of the items may be procured from M/s Shahzad Traders.
