In pursuance to Home Department, Government of Sindh, Karachi Order No.SO(A)HD-V(03)2014 dated 16.02.2016, relating to the constitution of Procurement Committee for Development Works under Rule-7 of SPPRA 2010, a meeting of Procurement Committee was scheduled under the Chairmanship of Chairman, Procurement Committee (Deputy Inspector General of Prisons, Hyderabad Range) on 29.07.2016 @ 03.00pm in the office of the Secretary, Procurement Committee (Project Director, Police & Prison Works, Hyderabad) at Shahbaz Building Block-A (2nd floor) Hyderabad to open the Bids.


2. Meeting was started with recitation of Holy Quran.
3. The Chairman, Procurement Committee asked the Secretary of Committee to brief the participants about the agenda.
4. The Secretary of the Procurement Committee informed the participants that Bids were invited from interested Bidders publically in Sindhi, Urdu and English National News Papers through Director of Information (Advertisement), Government of Sindh, Karachi as well as hoisting on official website of SPPRA and Information Technology Department, Government of Sindh for various Development schemes vide office of the Project Director, Police & Prison Works, Hyderabad letter No.PD(PPW)/ 585 Hyderabad dated 06.06.2016.

5. Accordingly bidding documents were issued to interested Bidders upto 1.00pm on 27.07.2016. The deadline for submission / return of bidding documents duly sealed and complete in all respects was given upto 2.00pm on 28.07.2016 for opening at 3.00pm on 29.07.2016 in the office of the Project Director, Police & Prison Works, Shahbaz Building Block-A (2nd floor), Hyderabad before the Procurement Committee and representatives of interested Bidders.

6. During today's meeting of Procurement Committee the Bids were opened accordingly and announced before the Committee Members and interested representatives of various firms and it was decided to recommend the rates of lowest Bidders to the competent authority for approval after due evaluation and scrutinization.
