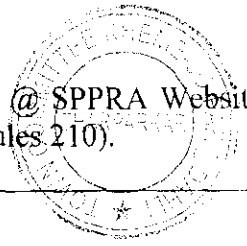

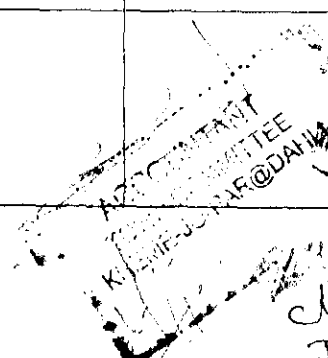

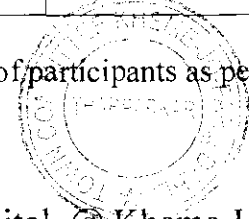
Minutes of Bid Opening Meeting
