

Undersigned informed the committee that in the light of decisions of the 1<sup>st</sup> meeting of the Committee, all the documents submitted by the participating firms with the tenders were checked and prepared firm wise list showing the status of each tender, the same is placed herewith before the committee for further necessary action.

The committee thoroughly examined / evaluates each tender and decided that all the participating firms may be contacted to complete the following missing / short documents / less CDR within 3 days. The same may be submitted in the next meeting, for further necessary action.



During the scrutiny & preparation of comparative statement of bids various items submitted by various firms through tender documents to the Superintendent, Livestock Development & Research Farm for Kundhi Buffaloes Farm Rohri, it was observed that the rates quoted by M/s, Indus Enterprises, Sukkur are found surprisingly low, which created doubts about the genuineness and seriousness of the Firm about business.

In view of the above, to ascertain the position concerned farm superintendent, constituted a committee to conduct survey of local market of Rohri / Sukkur cities to obtain the prevailing market rate of the commodities to be procured.

After the said survey the committee submitted its report accordingly which was also placed before the committee.


On consideration of the factual market position, the committee is of the opinion that M/s, Indus Enterprises, Sukkur is probably is not a serious business entrepreneur, and may create problem of supply after words. As such M/s, Indus Enterprises, Sukkur is deferred. However, the rest of three bidding Firm are considered for further procurements.





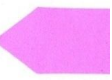

The meeting started as per schedule, Director General, Livestock Extension / Research Sindh / Chairman Procurement Committee welcomed the participants of the meeting and opened the discussion on agenda item for:-

Procurement of Animal Feed, Seed & Fertilizer for office of the Superintendent, Livestock Development & Research Farm, Kundi Buffaloes Rohri during the current financial year 2015-16.

Superintendent, Livestock Development & Research Farm, Kundi Buffaloes Rohri informed the firm that tenders were called through Newspapers for purchase of above items against the allocation of Rs: **51.98** Millions, provided under Regular Budgetary Provisions during the current financial year 2015-16.
