

GREEMENT

This Agreement is made on this 19th Day of May 2016 at Karachi 1.

BETWEEN

Police Department Government of Sindh represented on behalf of 2. Inspector General of Police, Sindh by Deputy inspector General of Police Training Range CPO Sindh Karachi operating from Central Police Office Sindh, I. I. Chandrigar Road, Karachi hereinafter referred to as the party of the First Part.

AND

- M/s Al Hakeem Builders office No. C-8 Shop No. 02 Rahat Com. Lane-1 3. Kahayaban-e-Rahat Defence Phase VI Karachi operating firm from hereinafter referred to as Party of the Second Part.
- WHEREAS, the Police Department Government of Sindh with the 4. approval of competent authority has been provided funds under head "Government Building/ Structure" during current financial year 2015-16 for Repair & Renovation work of DIGP Training Range Office & Allied Branches 10 Rooms.
- AND WHEREAS, as per terms & conditions of the agreement between 5. Government of Sindh (Police Department) and M/s Al Hakeem Builders office No. C-8 Shop No. 02 Rahat Com. Lane-1 Kahayaban-e-Rahat Defence Phase VI Karachi the said renovation wirk in required to be carried out in accordance with Government of Sindh, Sindh Public Procurement Regularity Authority (SPPRA) rules, policy and standing instructions on the subject. Accordingly, the Police Department floated tenders for the Repair & Renovation work of DIGP Training Range Office & Allied Branches 10 Rooms, covered under this agreement.

- 6. AND, the tenders were published in daily newspapers "Daily Kawish", "Daily Down" and "Daily Jang" dated 16-04-2016 and were opened by tender opening Committee constituted by the DIGP training, Sindh in presence of representatives/ agents of bidders at DIGP Training Conference Room of CPO building Sindh I. I. Chundrigar Road Karachi on 02-05-2016 at 1400 hrs.
- 7. AND, after evaluation of bids submitted by participating firms, the offer of M/s Al Hakeem Builders office No. C-8 Shop No. -02 Rahat Com. Lane-1 Kahayaban-e-Rahat Defence Phase VI Karachi for the afore said work amounting to Estimated cost Rs. **One Million** was found the lowest, and issue work order dated: 20th May 2016.
- 8. NOW THEREFORE, the party on first half agree to award the contract of the above work, as per terms and conditions and according to Government of Sindh, Sindh Public Procurement Regularity Authority (SPPRA) standard rules and regulations which have already been provided with tender documents and are again supplied along with this agreement, to the party of second half.
- 9. The party of second half has agreed to carry out the work at above locations as per scope of work provided by party of first half, and shall complete the work at all location within period of 20 days from the date of this agreement.
- 10. The party of second half shall keep the party of first half fully informed of the progress of work by submitting progress report on weekly basis or when ever required by the party of first half.
- 11. In case of any problem or hindrance in execution of work form any _____ sub-ordinate office of Police department, the party of second half shall immediately report the matter to Deputy Inspector General of Police Training Range CPO Sindh Karachi.
- 12. That party of first half shall be entitled to verify the work acceptance of bill and release of payment through committee or any outside professional firm/ authority.
- 13. That party of first half shall be entitled to point out and demand rectification of any fault in the work or material used in work, which the part of second half shall remove or change without any extra cost, provided such work in covered in the scope of work of the contract.
- 14. That all communication between the parties shall be in writing, and if posted to the given addresses shall deem to have been conveyed.
- 15. That in case of any difficulty both the parties can approach and consult each other to resolve any issue in the best interest of Government work by mutual consent in writing.

- 16. That party of first half shall have right to arrange inspections and monitoring of the works covered under this contract through Work Inspection/ Execution committee already constituted by the DIGP Training Sindh and the party of second half shall not have any objection to such visits/ inspections.
- 17. The repair/ renovation work has been handed over to the second party according to the rates and following conditions:
 - a) IF the work is left incomplete by the second party, the First party will hold its payment at any stage.
 - b) It is declared that the above named second party is the sole proprietor of the said company and the second party has no partner.
 - c) No payment will be released without inspection committee report.
 - d) The first party will not pay and amount if any excess work will be carried out by the second party without written approval of tender opening committee.
 - e) No bill will be entertained without pre-work and post-work photographs.
 - f) The second party will receive the payment himself.
 - g) All the old doors, windows, and pipes etc, will be counted for and kept under Safe custody till auction.
 - h) That the second party is fully bound to complete the work assigned to him within specified time, failing which the second party will pay 3% penalty of tender amount to the Government (Police Department).
- 18. IN WITNESS WHEREOF both the parties have got wet and subscribed their hand on this 19th Day of May 2016.
- 19. All relevant labour laws are observed by the second party and shall provide and thereafter maintain all appropriate medical treatment for its personnel involved in the subject civil work (if required).
