The meeting was convened to evaluate the bids for the work "INTERNAL AND EXTERNAL PAINTING WORKS AT URBAN & INFRASTRUCTURE ENGINEERING DEPARTMENT". A total of 06 bids were submitted, which were reviewed and evaluated in line with SPPRA rules as well as condition set forth in the bidding documents. Two bids i.e. Messrs Al-Shahbaz Engineering Services and Messrs Zilfa Engineering Services were rejected due to non-fulfillment of bid documents clause "P" (a) of bidding data sheet. Following are the comments:

1. Out of four accepted bids Messrs Zaidi Enterprises is the lowest evaluated bidder with total bid amount of Rs: 574,425/- inclusive of all taxes. The bid amount is 50% below then the estimated cost of i.e. Rs: 1,146,400/-.

2. The subject work may be awarded to Messrs Zaidi Enterprises being the

lowest evaluated bidder.


