
The meeting was convened to evaluate the bids for the work "Construction of Academic Block-II & Maintenance Shed for light vehicles". A total of 5 bids were received, which were reviewed and evaluated in detail by the project consultant M/S Shahzad Associates. Based on detailed technical evaluation and financial comparison of bids by the consultant, the procurement committee recommends that the work may be awarded to M/S G.Q.S Contractors for corrected bid price of Rs. 89,360,599/- which is 13% lower than the estimated cost of Rs. 102,873,000/-
