BID EVALUATION REPORT. TENDER FOR HIRING OF SERVICES – VEHICLES.

- The Tender for Hiring of Services of Vehicles was initiated for Operation & Maintenance (O&M) of 132 kV Double Circuit transmission line from Sindh Nooriabad Power Company (SNPC & SNPC-II) to K-Electric KDA-33 Grid Station. The total length of the Transmission line is around 95 kms.
 - A resolution through circulation was passed between 6th and 7th BOD Meeting on 17th March'2016 regarding Operation & Maintenance Implementation Plan required to be submitted to NEPRA in the Tariff Petition Public Hearing on 18th March'2016. The Board ratified the Resolution through circulation.
- 2. The Notice Inviting Tender (NIT) was published in various Newspapers of 08th and 11th May'2016. The bid opening date was fixed on 30th May '2016. As per SPPRA rules, the minimum of 15 days must be given to the bidders for the bid opening from the date of publication in the Newspapers which was fulfilled. (Copies enclosed as Annexure-A).
- Transparency International Pakistan raised a query vide letter No.TL16/1005/9A dated 10th May'2016 and requested to issue corrigendum. The Corrigendum was published in various Newspapers of 25th and 26th May '2016 in which the bid opening date was also extended up to 06th June '2016.
 (Copies enclosed as Annexure-B).
- 4. The Method of Procurement as mentioned in NIT was "Single Stage Two Envelope".
- 5. As per this Method of Procurement, the Technical and Financial Bids shall be sealed in separate envelopes by each bidder. The Technical Bid evaluation will be carried out first and Financial Bids of only Technically qualified bidders shall be opened in the presence of the Technically qualified bidders or their representatives.

- 8. The Procurement Committee carried out the Technical Evaluation of both the participated bidders and both bidders were Technically qualified: (Copy of Technical Evaluation Report attached as Annexure-D).
- 9. The Financial Bid of both the Technically qualified Bidders was opened on 15th July'2016 in the presence of both the Technically qualified Bidders.

The comparative offered bid amounts (including Sindh Sales Tax) of both the qualified bidders are as follows:

The bid Security asked in bidding document and NIT was 3% of the estimated cost/offered bid. The bid security submitted by Eirth Co Trading is Rs 1,062,617/- which is as per required bid security amount. Similarly, the bid security submitted by Super Traders is Rs 840,000/- which is also as per required bid security amount. Eirth Co Trading Company did not qualify the Financial Evaluation Criteria and hence its bid stands rejected.
