The bidding process was single stage one envelope as per (Rules 46(1) of SPP Rules-2010 amended in 2017), hence the bids were opened in front of bidders / representatives.

In the light of decision taken by of Procurement committees Five (5) bids of (2) two firms / contractors were opened on the above mentioned date & time. It was observed that, M/s K.K Construction Company did not submit CDR/ Pay Order/ Bank Guarantee for the bid of Regional Office of Shaheed Benazeerabad, whereas M/s Muhammad Hasni / Raza Muhammad also submitted Cross Cheque instead of CDR/ Pay Order/ Bank Guarantee for their bid of Regional Office Mirpurkhas, hence both the aforementioned contractors bids for the respective regional offices were rejected.
