Decision: Recommended to award 'Tender for Supply of Laptops for CDP, Govt. of Sindh' to M/s NK Computer at Rs. 871,000.00 (inclusive of taxes) and the minutes to be hoisted on IBA & SPPRA websites.



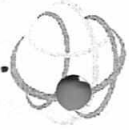
