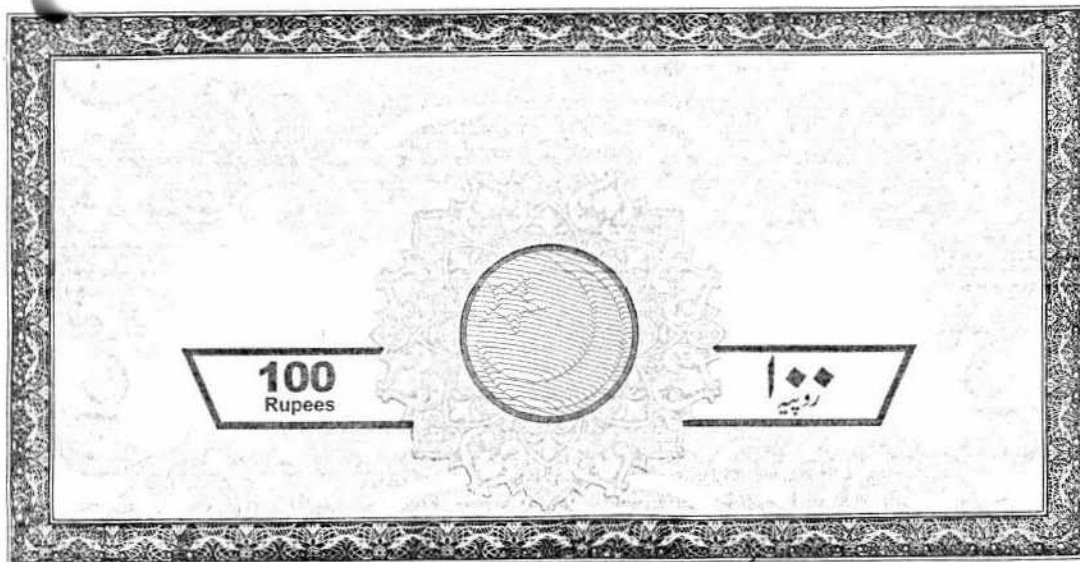

3. Medicine prescribed to patient on L.P. Slip shall be provided, according to prescription and no balance slip shall be issued to them and if such complaint is brought to the notice of Procurement Agency then it would be a breach of contract and the contract without notice will be cancelled.
4. Medicines / Drugs shall be stamped "Not for Sale", "Services Hospital Hyderabad", before providing to patients.
5. In case strength of the medicine / quantity is not mentioned in the requisition slip, better clarification be sought from this office or smallest packing of minimum strength should be supplied. In case of default the supplier will be paid for the minimum.
6. Full supply of the requisition will be made no piece meal supply with balance slip will be accepted.
7. No substitute will be accepted.
8. Supplier will have to sign an agreement and get the requisition slip as per approved format of this office printed and provide to this office in sufficient quantity no extra payment will be made for the requisition slips.
9. Income Tax will be deducted at the rates fixed by Government from every bill.
10. If any urgently required item is not supplied or supplied short it will be purchased from Local Market at market rates and the amount as per cash memo will be deducted from the bills pending for payment.
11. Signature of the authorized person who collects the medicines with C.N.I.C. NO: will be obtained on the back of the requisition slip to ensure correct delivery of the items.
12. Each bill will be for under Rs. 5000/- and will be submitted every week for making prompt payment.
