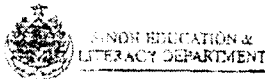




The box was opened at 2.00 pm by the Procurement Committee Members, in presence of interested bidders / representatives. All the sealed bids were opened.




