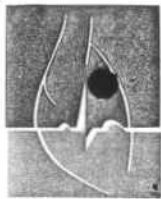



If the committee fails to arrive at the decision within seven days, the complaint shall stand transferred to the Review Committee as per SPPRA Rules 2010.
