- i) The Procuring Agency is required to prepare Annual Procurement Plan and proceed accordingly (without splitting/regrouping) as per requirement of Rule-12(2) of Sindh Public Procurement Rules, 2010 (amended 2017). In the instant case works at Sr. No:1,3,4,5 & 7 and Sr. No:2 & 7 (as mentioned in Annual Procurement Plan) have been regrouped together, which is violation of above provision of Sindh Public Procurement Rules, 2010 (amended 2017). Clarification/Justification is required.
- ii) Detailed comparative statement in terms of clause-11.3.3 of SPPRA Guideline is required.
- iii) Bidder's qualification report is not clear about the qualification of M/S Bahria Foundation because some column(s) remained blank. Clarification is required.
- iv) Response of this Authority's earlier letter dated 14.04.2017 (copy enclosed), is required.

2. It may be noted that it is the sole responsibility of procuring agency to carry all the public procurement by observing SPP Rules, 2010(Amended 2013), regulations and procedure in letter and spirit.
