The Committee was informed that sealed bids were invited through press for the procurement of 'Furniture/Fixture' for our Workers Model Schools (Secondary Level/ Primary level) and Two Intermediate Colleges located in Sindh. The tender notice was published in leading newspapers Daily 'Dawn' (English), Daily 'Express' (Urdu) and Daily 'Kawish' (Sindhi) on 13.04.2017 and 15.04.2017. The same was also hoisted/put on the website of SPPRA on 12.04.2017. However, due to some un-avoidable circumstances, the date of opening bids was extended from 2<sup>nd</sup> May-2017 to 11<sup>th</sup> May-2017. Corrigendum regarding extension of date have been published in leading news papers and also hoisted on the website of SPPRA.

Procurement procedure is based on Single stage - one envelope bids, containing Technical details and Financial Proposals, were invited for the purpose. Separate Bidding Documents were prepared and issued to interested firms on written requests. The bidding documents were also hoisted on the website of SPPRA.

Total (06) six firms have purchased tender documents for providing of furniture and out of which the following (02) two firms submitted their bids along with their company's profiles:-

- M/s. Aamir Traders.
- M/s. Al-Farooq Traders.

Committee opened the bids on 11<sup>th</sup> May-2017 at 02:00 p.m in presence of the Representatives of above named participated firms and announced quoted rates. Committee preliminary evaluated the bid technically with regard to availability of required documents; viz. NTN & Sales Tax Registration, business experience, dealing of bidding firms in supply of relevant stores, financial capabilities and the specifications of articles offered by the bidders etc. A comparative statement of the unit prices as quoted by the bidders has prepared by the Committee and during preparation of Comparative Statement is found discrepancy between unit price and total of the item No.01 in the BOQ of M/s. Aamir Traders i.e. as quoted by the firm as Rs.8,703,750/- whereas, actual total amount worked out after recalculation is Rs.17,452,500/-. Comparative statement is annexed with the minutes at "A". The detail of quoted prices by the participated firms as per comparative statement is reproduced below:-

i.	M/s. Aamir Traders.	Rs.32,738,923/-	1st Lowest.
ii.	M/s. Al-Farooq Traders.	Rs.44,885,835/-	2 <sup>nd</sup> Lowest.

The Budget estimate of the supply of furniture for the year 2016-17 is about 16.0 million whereas the lowest bid received is of Rs.32.739 million almost double from the budget value. The Assistant Secretary (Adm) proposed that the amount would be Reappropriated from other heads and lowest tender may be accepted as the year is near to completion otherwise the procurement/supply could not be completed during the year.

#### Decision

The Committee recommended the following subject to approval by Secretary WWBS:

- 1. Take prior approval for Re-appropriation of Account for 2016-17.
- 2. Send revised plan for annual procurement to SPPRA for hoisting on website.
- 3. To evaluate technically and substantial responsiveness of the specifications, material and quality of articles offered by bidding firms, Committee decided that a Committee to be nominated will inspect the samples of quoted articles, so as to ascertain & finalize the best evaluated bid in terms of timeliness, reliability, wood & sheets, structure, durability of material, polish, finishing and quality to meet the procuring agency's requirements.
