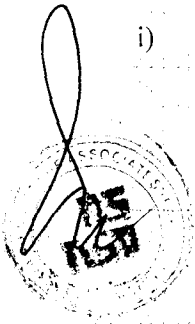


- ii) The method for bidding process was set as single stage-single envelop;

4. After the opening of bids received, following status was found:-


