- The meeting started with recitation from Holy Quran. The chair welcomed the participants and informed them that only two companies / firms (M/S Progressive Engineering Associates and M/S Link International) had obtained / purchased the Tender Documents. The chair further informed the committee that Technical Evaluation Committee has scrutinized all bidding documents submitted by the above mentioned both companies and submitted their report along with enclosures vide letter No. DVR/MR (14-A)/2015/PRNP/1848 dated 17-11-2015 (Appendix-A). It was unanimously decided to read the report of the Technical Evaluation Committee before the members of the committee and representatives of the companies. The report was read.
- 4. As per the report of the Technical Evaluation committee, M/S Link International obtained 35% marks whereas M/S Progressive Engineering Associates obtained 75% marks during the technical evaluation. The Technical Evaluation committee therefore, recommended M/S Progressive Engineering Associates whereas M/S Link International stood disqualified as a vendor should obtain at least 70% marks in over all Technical criteria.
- The M/S Link International and M/S Progressive Engineering Associates were given an opportunity to present their point of view if they have any reservations against the Technical Evaluation of their company. The representative of the M/S Link International asked about the details of the marks they obtained and the criteria of qualification of a company. They were shown the SPPRA rules and the details of the marks they obtained were explained to them. The representatives of both the companies agreed with the report of the Technical Evaluation committee.
- 6. It was unanimously decided that only the envelop marked as Financial Proposal submitted by M/S Progressive Engineering Associates may be opened and the envelop marked as Financial Proposal submitted by M/S Link International may be returned unopened to the representative of the company.
- 7. Accordingly, the envelop marked as Financial Proposal submitted by M/S Progressive Engineering Associates was opened and the rates quoted were readout. It was signed by all the members of the committee. The rates quoted for supply of Number Plates for 2/3 and 4 wheeler vehicles are as under:-

REPORT OF TECHNICAL PROCUREMENT COMMITTEE FOR THE PROCUREMENT OF NUMBER PLATES 2/3 WHEELER AND 4 WHEELER REPORT THEREOF.

The Administrative Department has constituted a Technical Committee for the Procurement of the 2/3 wheeler and 4 wheeler with certain ToRs as mentioned in the Notification No. SO(B&A0/E&T/7(55)/2013 dated 04-11-2015 and accordingly a meeting of the Technical Committee was held on 19-10-2015 at 03:30 pm in the office of the Director Excise, Taxation & Narcotics Control (Admn/MVR) Karachi (Annexure -A &B).

The envelopes containing bidding documents submitted by M/S Progressive Engineering Associates and M/S Link International along with the sample of Number Plates and the minutes of meeting of Procurement Committee of Number Plates 2/3 wheeler and 4 wheeler for the year 2015-16 received from the Administrative Department were opened and perused in detail for evaluation purpose.(Attendance sheet enclosed Annexure -C).

Following the parameter for the evolution criteria for the bidders described in the tender documents, the bidders documents were scrutinized in detail by all the members of the Technical Committee and every member individually awarded the marks, a consolidated statement of the marks obtained by each bidder is enumerated in (Annexure-D&E) whereby M/S Link International obtained 35 marks whereas M/S Progressive Engineering Associates secured 75 marks.

Moreover, regarding the mandatory requirement, both the bidders have furnished the N.T.N certificate and Sales Tax registration documents issued by concerned authorities.

As given in the bidding evaluation criteria the firm must get 70% i.e 70/100marks in Technical Proposal for qualifying. Accordingly, M/S Progressive Engineering Associates on securing 75 marks found eligible and technically qualified, hence, the committee decided to send the samples of Number Plates of 2/3 wheeler and 4 wheeler to Pakistan Standards Quality Control Authority for testing report as per specifications in the tender document.

Thus, on furnishing another pair of 2/3 wheeler and 4 wheeler number plates by M/S progressive Engineering Associates same were sent to Pakistan Standards Quality Control Authority for Test Report vide letter No.DVR/MR(14-A)/2015/PRNP/1682 dated 21-10-2015 (Annexure-F). Further as instructed by the Administrative Department vide letter No.SO(G)/CASH/ET&N/NUMBER PLATES/2015-16/2642 dated 27-10-2015 for sending the samples of other party (Annexure-G), M/S Link International were requested for providing two pair of Number Plates 2/3 Wheeler and 4 Wheeler each for test report which was not responded hence, the sample received from the Administrative Departmentalong with the bidding document were sent to Pakistan Standards Quality Control Authority for test report vide letter No.DVR/MR(14-A)/2015/PRNP/1700 dated 27-10-2015(Annexure-H).

The Pakistan Standards Quality Control Authority sent test report regarding registration Number Plates vide letter No. PSQCA/MISC/2015/1110 dated 06-11-2015 in respect of M/S Link International and vide letter No. PSQCA/MISC/2015/1111 dated 06-11-2015 in respect of M/S Progressive Engineering Associates concluding their findings in the columns of result for samples of 2/3 wheeler and 4 wheeler of both firms as (Average) for Sr. No. 1 to 10 and for Sr. No. 11 to 14 "on site verification" (Annexure-I&J).

Quality Control Authority Mr. Fahim Bari visited the premises of M/s Link International and M/S Progressive Engineering Associates mentioned in the bidding document (through intimation vide letter No. DVR/MR/(14-A)/ 2015/PRNP/1753 and No. DVR/MR/(14-A)/ 2015/PRNP/1754 dated 02-11-2015) enclosed as (Annexure-K&L)and found one premises of M/S Link International locked situated at Civic Centre Korangi whereas another premises bearing No. B-66 Zaman Town Karachi also visited and found thesame as a residential unit having no manufacturing activity. Thereafter, the premises of M/S progressive Engineering Associates located at North Karachi was visited and inspected in detail, regarding manufacturing facilities equipment and procedure and found that the premises was secured having calibrated equipment manufacturing facilities / capabilities and quality Control mechanism.

M/S Link International informed on telephone regarding their manufacturing unit which has not been mentioned in bidding documents and requested for inspection. Simultaneously, the Administrative Department vide Notification No. SO(B&A)/E&T/7(55) /2013 dated 06-11-2015(Annexure-M) co-opted Mr. Shaukat Suleman (CPLC Chief East Karachi) and included in the Technical Committee for the procurement of storesof durable goods and services, therefore, the premises of M/S Link International was visited by the Technical Committee in the company of Mr. Shaukat Suleman (Chief CPLC East Karachi) and Mr. Fahim Bari member from Pakistan Standards Quality Control Authority on 11-11-2015 situated at North Karachi Industrial area Karachi and found manufacturing of flask and to the items and installed equipment like hydraulic press, Air vacuumed Oven and Roller etc. however it was devoid of any paint shop and quality control facility(Annexure-N).

The team then visited the premises of M/S progressive Engineering Associates and inspected the facilitations regarding the equipment their capabilities certifications, quality, control, paint baking facilities, oven, Roller etc. and found a proper

mechanism of manufacturing of number plates (Annexure-O). The committee also verified the four remarks of "onsite inspection in the Test Report for Serial Nos. 11 to 14" mentioned in Para 6 supra and which is enclosed duly signed by all members as (Annexure-P)

On securing 75 marks and having well equipment manufacturing unit with the facility of quality control the committee has found M/S Progressive Engineering Associates eligible and qualify for further processing by the Procurement Committee..

The bidding documents in original in respect of both firms along with a piece of Number Plate 2/3 wheeler and 4 wheeler in respect of M/S Progressive Engineering Associates are returned herewith.
