M/s. Getz Pharama (Pvt.) Limited after rejection of their technical bid by the Government of Sindh filed a suit in which an interim order restraining the Government of Sindh from opening financial bid was passed on 09.06.2015 which order has been impugned in these appeal by the Government of Sindh as well as M/s. Roche Pakistan Limited a bidder. Consequently, after hearing all concern vide Order dated 24.08.2015 by consent we have called report from various Senior Doctors regarding safety, efficacy and potency of the Peginterferon Alpha-2A subject matter of the procurement.

In consequent to the Consent Order dated 24.08.2015, report has been submitted by Dr. Zaigham Abbas, Prof. Ghyas-un-Nabi and Prof. Abdur Rauf Memon regarding the safety efficacy and potency of the Peg-interferon Alpha-2A manufactured by M/s. Getz Pharma (Pvt.) Limited, Roche Pakistan Limited and Pooyesh Daron Company Tahran, Iran. Since the main contestant in the proceeding being M/s. Getz Pharma and Roche Pakistan Limited, consequently, we in presence of their counsel have gone through the report submitted by the panel of Doctors.



,



Dr. Zaigham Abbas has shown his inability to give report regarding head to head trial comparing safety efficacy and potency of the Peg-interferon sold by either party in the country, Dr. Abdul Rauf Memon has in his report stated that all three drugs are pegylated interferon Alfa 2-A and registered with the Ministry of Health and are expected to have same safety, efficacy and potency. He stated to have no experience of use of Iranian pegylated interferon, whereas, in respect of Roche Pakistan Limited and Getz Pharma (Pvt) Limited his comments are reproduced:-

"I have used Roche pegylated interferon which is also used in Europe and USA for several years with desirable results. I have used Getz pegylated interferon with lesser experience and probably similar results."

The third Member of the panel i.e. Prof. Ghyas-un-Nabi has given a very extensive report in respect of drug manufactured by all three companies which is reproduced below:-

"Pegylated Interferon alpha 2a 180 mcg previously marketed as Pegasys by Roche Pharma Limited, now available with the name of Ropergra has been extensively studied and used at international and national levels and its safety, efficacy and potency is consider to be gold standard.

Pegylated Interferon alpha 2a 180 mcg marketed by Pooyesh Daron Co, Tehran, Iran with the name of Pegaferon has been studied and used extensively in Iran and Pakistan and no concern about safety, efficacy and potency have been raised. In the clinical studies / Phase IV publications in various scientific journals, its safety, efficacy and potency has been found comparable to the product mentioned in paragraph number 4.

Pegylated Interferon alpha 2a 180 meg marketed by Getz Pharma (Pvt) Limited with the name of Unipeg is registered and available in Pakistan only and has been used by number of practitioners. Various Phase IV clinical studies have been presented as abstracts at National and International meetings and no concern about safety, efficacy and potency have been shown in any of these studies. No publication has been made in any of the medical journals in support of safety, efficacy and potency of this product.

There has been no head to head comparatives trials comparing these products having biosimilar molecules at any time have been done which may enable me to guide the court to compare the relative safety, efficacy and potency of these three products."

Perusal of the report does not from any angle reflects that the drug manufactured by M/s. Getz Pharma is spurious or not safe for human consumption or which could be rejected for want of safety, efficacy and potency, however, the product of Roche as it appears from the report is being used internationally with desirable results, has been extensively studied and used at international and national levels



and as stated by Dr. Ghyas-un-Nabi its safety, efficacy and potency could be considered to be of gold standard and for this reason it may have an edge on the product of M/s. Getz Pharma and for this reason perhaps its market price appears to be almost 75% more than the price of Getz Pharma drug. Both companies viz. Roche Pakistan Limited and Getz Pharma (Pvt.) Limited keeping in view that the drugs are to be used for the poor and deprived class have voluntarily offered to reduce their prices (which they have quoted and are yet to be opened) by 12.5% and 20% respectively.

Both the learned counsel have earnestly submitted before us that the litigation is not for profit earning, as the prices quoted are so low and further reduced, hardly meets the cost. Mr. Siddiqui contends that rejection of M/s. Getz Pharma's technical bid is a stigma on their product which has compelled the Respondent to approach this Court, however, the most important aspect which needs to be considered is that the interim order passed in these proceedings had adversely effected poor and deprived class specially those incarcerating in prisons for whose curement the instant injections are being procured.

In these circumstances, the technical committee of the Respondent would reconsider the order rejecting the technical bid of M/s. Getz Pharma (Pvt.) Limited keeping in view the observations made hereinabove and if they find them entitled would open their financial bid as well. Notwithstanding, if their technical bid is still rejected the financial bid of the remaining bidders would be opened and procurement order would be placed forthwith. The appeals in above terms are allowed to the extent as above and by vacating the ad-interim order passed by the learned Single Judge restraining the procurement process. However, this order is without prejudice to the rights of the Respondent M/s. Getz Pharma (Pvt.) Limited to pursue its course in accordance with law.


