





The Firms / Consultants having vast experience in Designing / Supervision for construction of water purification plants in preparing bidding documents and evaluation of Contractors or who is eligible for participation in shortlisting.

5. The consultant having renewal Certificate of PEC for the year 2016, with the allocation of Code No. 1205 shall only be eligible for participation in shortlisting of Civil Engineering Consultants for proposed consultancy services.

6. The consultants must have the latest GIS with Hydro analysis licensed softwares for Slope Stability Analysis, Finite Element Seepage Analysis System, FEM Seismic Analysis, HEC-RAS & HEC-HMS along with its complete knowledge of operation.
