








**MINUTES OF THE MEETING OF PROCUREMENT COMMITTEE REGARDING FINANCIAL EVALUATION FOR  
PROCUREMENT OF RELIEF GOODS 2016-17 HELD ON 05.07.2017 (SPPRA ID# 33183).**

A meeting of procurement committee of PDMA Government of Sindh was held on 05.07.2017 at 11:00 am in the committee room of PDMA Sindh under the Chairpersonship of Mr. Uzma Ismail, Director (F&A), PDMA Sindh/ Chairperson PC and in the presence of the bidders who were technically qualified (attendance sheet of the participants and the bidders is attached).

In the light of decision of technical sub committees and lab reports, financial bids of Eight (08) firms / contractors were opened on the above mentioned date & time. Whereas, financial bid of Seven (07) firms were not opened being technically disqualified (Report of PCSIR Lab is attached) and were returned unopened.

Furthermore, there was only one technically qualified bidder for the NIT item No 6 (Walkie Talkie Set) for which the quoted prices were compared with the market price of the items/ equipments and was found acceptable by the Procurement Committee.

The Procurement Committee unanimously decided that the item wise required quality and specifications mentioned in the tender documents for purchase of relief goods 2016-17 would be strictly complied. The comparative statement of rates of firms are placed at Annexure-A. The detail of the firms whose financial bids were opened and their quoted rates are as under:





MINUTES OF THE MEETING OF THE PROCUREMENT COMMITTEE FOR THE PURCHASE  
OF RELIEF ITEMS/ GOODS HELD ON 04.05.2017.


The meeting of the Procurement Committee for purchase of relief items for PDMA Sindh was held under the Chairmanship of Director (F&A), PDMA Sindh in PDMA Head office Karachi on 04.05.2017 at 11:30 pm. List of the participants is attached.


2. The Chair welcomed the participants to the meeting. The Chair apprised the participants that monsoon season and possible Heat Wave is approaching therefore, it is imperative that the PDMA is fully endowed with requisite materials to meet the challenges ahead. The committee was also informed that the Headquarter Engineering 5-Corps and Pakistan Navy has already placed its demand/list of urgent procurements to the PDMA. To meet the same, PDMA initiated a tendering against NIT dated: 24.02.2017 in which bids/ proposals of certain items i.e. Pneumatic / Inflatable Rubber Boats, OBMs, Plastic Mats/ Chatai, Search Lights & Walkie Talkie Sets were not opened due to technical disqualification by the Procurement Committee. In this regards, a fresh tender is being floated for the said items. During the course of meeting it was further apprised that the main purpose of this meeting was to finalize specification of the goods, quantity mentioned therein, the bidding document, date of publication of NIT, last date of collection of bid documents, last date of submission of bids and opening of tender, tender fees and method of procurement. (Working paper is enclosed)


3. A draft bidding document that includes all ToRs and detailed specification was placed before the PC, which was examined and discussed at length. It was also pointed out that the Bidding Document were finalized in light of the past experience. The PC, after deliberations, took the following decisions:


- i. Procurement of relief goods as per NIT with specification and was minutely examined and mutually agreed upon after minute changes "Annexure-A".
- ii. The bidding documents was also minutely examined and the PC was unanimously finalized and agreed upon which may be perused at "Annexure -B".
- iii. The draft Tender Notice was also examined and unanimously approved by PC.
- iv. The PC decides the dates as under:
  - a. Date of publication of Tender Notice was finalized i.e. 09-05-2017 (subject to timely submission to Information Department.
  - b. Last date of collection of bid documents: 24-05-2017 till closure of business hours.
  - c. The last date of submission of bid: 25.05.2017 upto 1200hrs.
  - d. Date of opening of tender: 25-05-2017 at 1300hrs.
- v. The tender fee was finalized at Rs.3000/- non refundable for each item.
- vi. The tender will be single stage two envelopes.


- vii. Tender will be opened at PDMA Head office Karachi, i.e. Bunglow No. 82, Lane No. 10, Khayaban-e-Hilal, DHA, Phase-VI, Karachi.
- viii. Bid evaluation criteria available on SPPRA website was examined and decided for adherence while evaluating the proposals.
- ix. The successful bidder will have to deposit performance guarantee to the tune of 5% of the quoted value at the time of award of contract.
- x. A Technical Sub Committee will be constituted for Technical evaluation/ assessment of the tendered items. The service of any concerned agency / co-opted member may be hired for this purpose. One or more sub committees / labs may be constituted to verify the quality of the stocks as per technical evaluation and assessment report of the samples, by the subcommittee / labs.
- xi. The PC will start evaluating technical proposals following the next day of opening of tender.

MINUTES OF THE MEETING OF PROCUREMENT COMMITTEE HELD ON 25<sup>TH</sup> MAY, 2017 FOR  
OPENING OF TENDER OF PDMA SINDH

A meeting of the Procurement Committee constituted in pursuance of rule 7 of the SPPR Rule-2010 and notified vide No. PDMA(S)/5-7/2017, dated:09.02.2017 regarding purchase of relief/rescue items was held under the Chairpersonship of Mr. Uzma Ismail, Director (F&A), PDMA Sindh/ Chairperson PC, on 25<sup>th</sup> May, 2017 at PDMA Head office Karachi at 01:00 p.m. for Opening of tenders as per schedule communicated vide NIT published in leading daily newspapers, and hoisted on PDMA website and SPPRA website (SPPRA ID# 33183).(The list of the participants in attached).

The chair welcomed and apprised the participants that only the technical proposals will be opened in the presence of the bidders and their evaluation by the procurement committee will be done in due course of time and financial proposals of only those bidders who qualify successfully in the technical evaluation will be opened. The Chairperson PC apprised the committee that 12 vendors obtained the bidding documents from PDMA Head office, Karachi on submission of non refundable Tender Fee amounting to Rs.3000 per item. It was further apprised that 05 bids have been received from bidders who downloaded the Bidding Documents and have submitted their proposals accompanied by Tender Fee vide Pay orders before closing time of submission of bid i.e. 12:00pm, making the total bids to 17. However, on the scheduled date all 17 bidders have participated in bidding process. The attendance sheets of the PC & bidders are attached as Annexure-1 to 4.

As decided earlier in the first Procurement Committee meeting held on 04.05.2017, the bidding process was single stage two envelope as per (Rules 46(2) of SPP Rules-2010 amended in 2017), hence the bids were opened in front of bidders / representatives, whereby the technical proposals were opened and financial bids were kept in safe custody. The proposals were opened for the items from serial no; 1, 2, 3, 4 & 6 of NIT, however no bid was received for (item No.05) Search Light.

The committee on the basis of evaluation of tender documents, took following decisions:

During the scrutiny, it was found that the 2 (two) bids were not in conformity with rule 46 (2) & 47 (2) of SPPR Rules-2010 (amended-2017) because of the fact that they failed to comply with the basic requirement of said rule, therefore the same were rejected by the PC and returned to the bidders. The details of the rejected bids and reasons are as under:
