8. Steel free from all kinds of rust and cement free from all impurities which conform to the British Standard specification shall only be allowed to use.
9. All reinforced cement concrete work shall be mechanically vibrated so as to have minimum compressive strength of 3000 lbs per Sq: inch.
10. Sand from only approved quarry shall be used in all items involving use of cement, pit sand shall not be allowed to use.

11. **Sweet and potable water** only shall have to be used in construction work which is to be arranged by the contractor.
12. **The bid money** of 2% of the bid value submitted by you will be treated as "Performance Security" **Remaining 8% amount** will be deducted from each running bill as security deposit.
