Meeting started with recitation from Holy Quran. The Committee was informed that as per the SPPRA rules 4.3, procurement over One Hundred Thousand Rupees and up to the limit of One Million Rupees shall be advertisement by on the Authority website as well as procuring agency's website. Accordingly to the above rules, the sealed bids/quotations were invited through hosted procuring agency's website and SPPRA website as on 02.06.2017 at serial No.32848.

In response to advertisement, Three (03) interested firms purchased the tender documents, and submitted their bids (Attendance Sheet annexed at "A"), which are as follows:

- 1) M/s. Bin Sajjad
- 2) M/s. USS Enterprises, Karachi
- 3) M/s. Bilal Enterprises,

The bid was opened by the Procurement Committee on 21.06.2017 in presence of the representative of Bidding Firm and the rate quoted by bidders was announced. Committee preliminary evaluated the bid technically with regard to availability of required documents; viz. NTN and Sales Tax Registration, business experience and dealing of firms in supply of similar stores, committee has satisfied after preliminary evaluation of the documents submitted by the bidder.

During the opening of tender it has been observed that all three bidders who have quoted the rate of different manufacture of spilt units so therefore, we can't be comparison in term of lowest bidders. Keeping in view of the above position a committee first decides in which split be purchased then committee able to making recommendation for procurement, while detail discussion a committee has proposed that spilt of manufacturing of "Gree Company" shall be procured due to which the above model of spilt more durable from the Haier, Dawlance and Pel none of bidders who have quoted the rates about Mitsubishi. However, the rates quoted by all the three firms were announced by Committee, as the different manufactures. Comparative Statement of rates quoted by all the bidding firms is annexed at "B"). The contents of comparative are as under:
