MINUTES OF POST BID / EVALUATION CRITERIA MEETING

Post Bid Meeting regarding observing evaluation / qualifying criteria for bid published vide NIT No.TC/G-55/385, dated:10.04.2018 held on 02.05.2018, in the office of the Executive Engineer Highways Division Shikarpur under the chair of Executive Engineer Highways Division Shikarpur and other Members, Assistant Engineer Provincial Highways Sub-Division Jacobabad, and Assistant Executive Engineer Irrigation Choi Sub-Division Shikarpur.

The eligibility conditions required in NIT referred above have been scrutinized in detail, where-in the contractors who possessed such eligibility conditions were declared responsive. However who failed to match the required conditions were declared un-responsive.

The Committee further scrutinized the following standard criteria.

1. The Pakistan Engineering Council Certificates were strictly observed being qualified having validity period beyond May 2018, however the participants submitted the PEC Certificate having exclusion considered.
2. The only bid security in shape of call deposit, pay order and bank guarantee from recognized standard bank of Pakistan of required amount were entertained. Hence deficient amount or guarantee from un-recognized institution were declared un-responsive.

The Committee concluded the meeting with a vote of thanks.



Nawaz, Tareen disqualification is for life, rules SC

ISLAMABAD: In a landmark verdict that will change the course of the country's political history, the Supreme Court on Thursday ruled that disqualification handed down under Article 62 (1)(D) of the Constitution is for life, the verdict was issued unanimously by all five judges of the bench. Article 62(1)(D), which sets the precondition for a member of parliament to be "sadiq and ameen" (honest and righteous), is the same provision under which former prime minister Nawaz Sharif was disqualified by a five-judge SC bench on July 28, 2017.

Likewise, Pakistan Tehreek-i-Insaf (PTI) leader Jahanگیر Tareen was disqualified on Dec 15 last year by a separate bench of the apex court under the same provision. Following the verdict, both Sharif and Tareen have been deemed ineligible to hold public office until the courts' respective declarations against them hold.

Will continue taking suo motu notices: CJF

ISLAMABAD: Chief Justice of Pakistan Mian Saqib Nisar has shown his determination to continue taking suo motu notices on matters of public interest. The top judge made the remarks during the hearing of a case pertaining to pensions. "I will keep taking suo motu notices on education, clean drinking water, health care, etc."

Lahore: The National Accountability Bureau (NAB) Lahore chapter has summoned former prime minister Nawaz Sharif over allegedly abusing powers as the chief executive of the country hours

Nawaz terms SC judgment expected and vengeful

Lahore: PML (N) leader Nawaz Sharif has responded to the Supreme Court judgment by terming it expected and vengeful. Talking to workers at his residence in Jait Umra, Nawaz Sharif said that no one can snatch people's leadership from them. "It is apparent that the target of all these judgments is my person," he said.

Shah announced the verdict. A five-member larger bench, headed by Chief Justice of Pakistan Justice Mian Saqib Nisar, had reserved the verdict while hearing several petitions to determine the time-period after which would remain disqualified for other being de-seated in violation of Article 62(1)(D) and other election laws. During the hearing, the court had observed that the disqualification will continue for as long as the declaration signed by Nawaz Sharif and Jahanگیر Tareen is in force. The court also passed in 2010, did not determine a time period for disqualification.

Bomb kills five during football match in Somalia
MOGADISHU: A bomb killed up to five spectators at a football match in southern Somalia, police and a lawmaker said on Friday. The first time an explosion has targeted a stadium. The blast went off in the port town of Barawe, in the Lower Shabelle region, when residents were watching a football match on Thursday afternoon, police said, adding that at least five people were killed and 10 injured. The bomb killed five people and injured a dozen others in the football field. All the casualties were from the outskirts, Mahad Dhooje, a lawmaker for South West state told. A spokesman for the police said that the target was not there at the time of the match. The bomb looked like a remotely controlled one that was planted here, Aden told Reuters from Barawe.

Taliban attacks kill 13 policemen in Afghanistan

KABUL: Taliban attacks on Wednesday killed 13 policemen and wounded several others, officials said Friday. In western Helmand province, 10 policemen were killed and four were wounded in Shindand district.

ISLAMABAD: Security forces are on high alert in the capital and other major cities in the wake of the 18th Amendment. The government has ordered all districts to be especially vigilant and to conduct regular intelligence collection, random searches and mobile patrolling.
