

MEETING OF CONSULTANT SELECTION COMMITTEE - CONSULTANCY SERVICES FOR "DEVELOPING TRAINING MODULES IN ALIGNMENT WITH THE SPPRA TRAINING STRATEGY" AND REVIEW, UPDATION AND PREPARATION OF PROCUREMENT REGULATIONS, STANDARD BIDDING DOCUMENTS AND OTHER PROCUREMENT RELATED DOCUMENTS".

A meeting of the Consultant Selection Committee was convened on Wednesday 28th September, 2016 at 1100 hours in the Committee room of Sindh Public Procurement Regulatory Authority, Barrack No.8, Sindh Secretariat No.4-A, Court Road, Karachi for reviewing the evaluation of Expression of Interest received in respect of hiring Consultancy services for "Developing training modules in alignment with the SPPRA's Training Strategy and Review, updation and Preparation of procurement regulations and standard bidding documents and other procurement related documents under Sindh Public Sector Management Reform Project (SPSMRP).

At the outset of the meeting, Mr. Jawed Sibghatullah Mahar, Director (Admin & Finance), Sindh PPRA informed the committee that a meeting to review the evaluation criteria was held on 27th September, 2016 at 11:00 a.m. under the Chairmanship of Secretary, Finance Department, Government of Sindh, wherein the Terms of Reference of the assignment and evaluation carried out by the CSC were discussed and Chair suggested to the CSC to review the evaluation criteria and bring it more closer to the targets of DLI under Sindh Public Sector Management Reform Project IDA Credit # 5584-PK.

3. The Consultants Selection Committee reviewed the evaluation criteria as per the suggestions received during the meeting held under the chairmanship of Secretary Finance. The committee while re-evaluating the proposals also considered / discussed the comments received from Ms. Uzma Sadaf, Senior Procurement Specialist, the World Bank and clarification / additional information received from the firms. Accordingly, the consultant selection committee has prepared a shortlist of the firms, which is enclosed as Annexure-A. However, the list of top three firms along with marks obtained is as under:




