North Sindh Urban Service Corporation (NSUSC) Limited's invitation for Bid for the "Procurement of Solid Waste Collection Equipment" was advertised in daily "Kawish" on 17 Oct. 2010 and in daily "Dawn" on 18 Oct. 2010. The IFB was also hoisted over Asian Development Bank (ADB) and NSUSC website. The principal funding source for financing this procurement is a loan from the ADB. The mode of this procurement was International Competive bidding under ADB's One-Stage Two Envlope bidding procedure.

2. Following two bidders out of 04 who purchased the bidding document participated in the bidding procedure and submitted its proposal before the submission dealine of 11 AM on 02 Dec. 2010. As such, under two envlope bidding only technical proposals of these bidders were opened before the NSUSC procurement committee, representative of bidders, and public/stake holders at 11:15 AM on 02 Dec. 2010, .

Bidder A: M/s. Hinopak-CHIL JV

Bidder B: M/s Automobile Corporation (Pvt.) Ltd

3. The procurment comprised of following two lots and for each lot seprate bid security was called

from the bidders.

Lot 1: 33 Nos. Side Loading Trucks Including 430 Nos., 3.5m³ SKips

Lot 2: 07 Nos. Rear Loading Trucks Including 90 Nos. ,7m³ Skips

4. Evaluation of 1st Stage Proposals were carried by NSUSC Procurement Committee, assisted by International Consultant M/s. Posch and Partners, Austria, Following are the results of 1st stage technical proposal evaluation.

^{*} The shape and skip container design for Lot 1 submitted by the Bidder A is not substantially responsive as required under Section-VI of the bidding document. As such "i) During the discharging the skip wall adjacent the discharging edge must have a minimum tilt angle of 50 (with the discharging edge being the lowest point of the skip)", ii) Minimum length: 1.9 m +/- 1%, Maximum length 2.3 m +/- 1% but not greater than the width of the truck chasis". . The Bidder A vide his clarification to the evaluation query in this respect could not satisfy the condition thus his bid for lot 1 is not accepted.





- **5.** The price proposal opening as per above evaluation results was set on 11 Dec. 2010. Both the bidders were accordingly informed about the price proposal opening vide NSUSC letter Nos. NSUSC/O&S/Proc./ICB/2010/1420 & 1421 dated 09 Dec. 2010. The **Bidder A** was informed about technical evaluation results in respect of its bid for Lot 1 found as technically non-responsive vide letter No. NSUSC/O&S/Proc./ICB/2010/1433 dated 11 Dec. 2010. As such the price proposal of **Bidder A** was not disclosed/announced in price proposal opening held on 11 Dec. 2010 at 13:00 hrs at Committee Room, NSUSC head office.
