

The meeting started with recitation from Holy Quran.

At the outset the chair welcomed the participants and informed that the Additional Relief Commissioner Sindh, vide letter No.R/F-359 dated 19-6-2017 sent a copy of Summary bearing No.PS/SMBR/13 dated 26-5-2017, duly approved by the Honourable Chief Minister Sindh to the Secretary Food Department, Government



of Sindh for releasing quantity of wheat to the Deputy Commissioner Tharparkar for distribution. That the Additional Relief Commissioner Sindh under his subsequent letter No.R/F-363 dated 20-6-2017, moved the Deputy Commissioner Tharparkar for lifting and distribution of 287,946 wheat bags of 100 kgs free of cost on one time basis at the scale of 100 kgs bag per family considering the fact that malnourishment and very poor birth spacing. That as per past practice, the transportation loading and un-loading charges of wheat from food godown to the respective Relief Centers in the District will be borne 24-6-2017 and Dawn dated 25-6-2017.

Total 33 Contractors participated, out of which 28 filed tenders on 14-7-2017 at 12-00 Noon and were opened by the Committee on the same date at 1-00 pm in presence of all the Tenderers.


