A meeting of Technical and Financial Evaluation Committee (TFEC) for outsourcing of District Headquarter Hospitals\Other Hospitals to Health Management Organization (HMOs') in Sindh under Public Private Partnership (PPP) Mode was held on 21st May 2018 at 10:00 AM at the office of Secretary, Health Department, Government of Sindh under his chairmanship. The meeting was convened to finalize and approve evaluation of the Prequalification Applications (PAs) received for the Project. The attendance sheet copy is attached as **Annexure-A**.
