


After detail discussion and deliberations the following resolution was unanimously passed:


### **Resolutions:**



3. Resolved that, a copy of minutes shall be provided to SPPRA for hoisting in accordance to settlement of issue/complaint and same be placed on record.


The meeting then ended with the vote of thanks to members and to the Chair.
