A meeting of Consultant Selection Committee (CSC) was held under the Chairmanship of Director General, Directorate of Urban Policy & Strategic Planning (UP&SP), Planning & Development Department, Government of Sindh on 8th November, 2016 at 3:00 PM in the committee room of the Directorate for evaluation of Expression of Interest (EOIs) submitted by the interested individual consultants – experts for Resettlement Policy Framework (RPF) Study For Karachi Quick Wins Project Under Karachi Transformation Strategy.

2. The Secretary, Consultant Selection Committee informed the Committee that a total of five (05) individual consultants had submitted the EOIs. The CSC thoroughly examined and evaluated the EOIs submitted by interested individual consultants. The EOIs were evaluated as per criteria given in EOI issued: which included 30 marks for General Qualifications (including registration with relevant professional body), 50 marks for Relevant professional experience, 10 marks for Experience in region and 10 marks for Experience with International organizations or donor agencies (WB, ADB, USAID, etc) (a total of 100 marks). In case the CSC invite the candidate for interview and presentation, 70% weightage will be assigned to above 100 marks and 30% weightage will be assigned to interview and presentation session.

3. Based on the evaluation of EOIs submitted by the interested individual consultants, the CSC finalized the ranking of the individual consultants as below:
