Meeting started with recitation from Holy Quran. The Committee was informed that as per SPPRA rules 4.3, procurement over One Hundred Thousand Rupees and up to the limit of One Million Rupees shall be advertised by on the Authority's website as well as procuring agency's website. Accordingly to the above rules, the sealed bids/quotations were invited through hoisted on procuring agency's website and Authority's website as on 03.07.2017 at Sr. No. 33853.

In response to advertisement, two (02) interested firms purchased the tender documents, and submitted their bids, which are as follow: (Attendance Sheet annexed at 'A')

1. M/s. Hi-Tek Computers, Karachi

2. M/s. Asahraf Traders, Karachi

The bid was opened by the Procurement Committee on 20.07.2017 in presence of the representatives of Bidding Firms and the rates quoted by the bidders were announced. Committee preliminary evaluated the bid technically with regard to availability of required documents; viz. NTN and Sales Tax Registration, business experience and dealing of firms in supply of similar stores, committee has satisfied after preliminary evaluation of the documents submitted by the bidder.

After evaluation of the specification furnished by above two firms with regard to quality and brand, both the bids were found acceptable. Accordingly, the rates were announced by the Committee, as the bids were invited on single stage-one envelope method of procurement.
