2. During the scrutiny of financial proposals and technical documents following observations were made:

- The financial bid of M/s. Baz Muhammad Khan & Company for Construction of 08 Quarters/Houses for clerks/Assistants/Supervisors found incorrect and was differing from bid of Rs. 23,320,119.08, announced on 22 November, 2016. The correct bid is found at Rs. 22,723,344.67.
- The financial bid of M/s. Baz Muhammad Khan & Company for Construction of 08 Quarters/Houses for Sweepers found incorrect and was differing from bid of Rs. 13,275,467.00, announced on 22 November, 2016. The correct bid is found at Rs. 13,273,932.59.
- The rates quoted by M/s. Baz Muhammad Khan & Company were examined by the Civil Engineer and are found front loaded.
- The rates in both tenders/bids are quoted abruptly.
- M/s. Baz Muhammad Khan & Company did not follow the instructions to the tenderers provided in the tender/biddings documents.
- M/s. Baz Muhammad Khan submitted the invalid affidavit for declaration of blacklisting which was mandatory requirement. It is clearly mentioned in the Tender/Bidding documents that the firm(s) will be rejected for not submitting valid mandatory requirements/certificates/affidavit.
- M/s. Baz Muhammad Khan & Company could not obtain the minimum points/score to qualify technically.
- All other firms were found technically qualified as mentioned above.

3. The Procurement Committee thoroughly discussed the Bids and technical documents of M/s. Baz Muhammad Khan & Company and rejected their financial bids and technical documents. After rejecting the bids of M/s. Baz Muhammad Khan & Company the final results was as under:
