1. <u>INTRODUCTION</u>

The Karachi Water & Sewerage Board conceived Greater Karachi Sewerage Plan (S-III) to Rehabilitate / Upgrade the Sewerage System of the City. The Project includes an Integrated System for the collection / conveyance, treatment and disposal of sewage through Construction of Collector Drains, Interceptors, Trunk Sewers and Sewage Treatment Plants. The Greater Karachi Sewerage Plan (S-III) aims to convert Karachi into an echo friendly city by cleaning its breaches and improving marine ecology as well as provide better hygienic conditions in the city.

KW&SB planned different Contract Packages for the implementation of S-III Project, of which few are ongoing Contract Packages at site. Upon approval of Revised PC-1 from ECNEC Forum, on 7th February 2018 execution of the remaining proposed Contract Packages Planned. In this regard, Pre-Qualification of Firms notice through publication in Press was invited from interested Contracting Firms to submit their Pre-Qualification Documents to eligible themselves for participate in the bidding of Remaining Works proposed under Greater Karachi Sewerage Plan (Revised PC-1).

Standard Procedure for Pre-Qualification of Contractors is the documents prepared by Consultants, in the line with the SPPRA Rules 2010 (Amended 2017) and the guidelines of Pakistan Engineering Council (PEC), thus minimizing ambiguities and likely contractual issues.

The Notice for "Invitation for Pre-Qualification" was published in the leading Newspapers.

2. PROCESS FOR PRE-QUALIFICATION

In accordance with the decision of the Competent Authority, the Pre-Qualification Evaluation Process was to be invited for remaining works after approval of Revised PC-1 and issuance of necessary Administrative Approval on 6th March 2018. The Pre-Qualification Documents were prepared in accordance with the guidelines of Pakistan Engineering Council, SPPRA Rules, 2010 (Amended 2017) and in consultation with Pre-Qualification Committee constituted in accordance to Clause-7 of SPPRA Rules 2010 (Amended 2017). The Pre-Qualification Documents issued to the applicants are enclosed at the end of this report.

Accordingly, Notice of invitation for Pre-Qualification was published in the leading Newspapers on 27th February, 2018.

2.2 **DETAILED EVALUATION**

2.2.1 Evaluation Criteria for Pre-Qualification

The Pre-Qualification applications were invited by Project Director, Greater Karachi Sewerage Plan (S-III) Project of Karachi Water & Sewerage Board for the Design, Procurement, Installation, Construction, Commissioning and Operation for specific period of new Sewage Treatment Plant proposed at Korangi (Malir Basin). The following weightage will be used in the Evaluation of the submission for Pre-Qualification.

2.2.3 The Scoring System

As per the Evaluation Criteria the following scoring system was used to evaluate each contractor whose documents have been declared responsive.

A) Qualification of Firm

a) General Experience

- (i) In this part of the category the applicants were required to submit proof of the similar nature works executed during the last 10 years, of specified capacity / size.
- (ii) Proof of In-house Design Capacity or Provision of designing sewage treatment process and plant.
- (iii) A brief about the understanding they developed for the execution of project.

b) Personnel Capabilities

A list of required Construction / Technical Staff was included in the Pre-Qualification explaining the weightage points for their qualification and experience and the applicants were required to submit their CVs.

c) Equipment Capabilities

Under this heading essential equipment was specified and in case of its ownership 100 marks were to be awarded while in case of the plant and machinery being hired 70% marks were to be awarded.

d) Financial Capabilities

- i) The applicants were required to submit their audited accounts for the last (3) three years.
- The applicants were required to submit the Bank Letter mentioning credit limit capacity available to complete the project.



e) For Joint Venture

In case of Joint Venture it is mandatory for leading partner to meet 60% of qualifying criteria for Financial Capability. The remaining partner of Joint Venture was required to meet not less than 40% of all the qualifying criteria given in 3.2.5.

2.2.4 Applications Submitted for Pre-Qualification

In response to the invitation for Pre-Qualification total 19 Contractor's Firm submitted their documents for Design, Build and Operate.

2.3 **DETAILED EVALUATION**

- 2.3.1 The detailed evaluation of Responsive Contracting Firms was carried out in accordance with the Pre-Qualifying Criteria as mentioned in the documents provided for Pre-Qualification of Contractors.
- 2.3.2 The Pre-Qualification Evaluation Committee suggested the following conclusion to be implemented after consensus in the detailed Evaluation of the Applicants.
 - i) The projects involving "expansions in capacity of Sewage Treatment Plant" are to be considered as similar nature projects i.e. new plant construction.
 - ii) The applicants who have executed the contract as Sole Contractor or lead partner in Joint Venture are considered as contractor of that project. The score shall be given in respect of In-house design facility to those project executed under EPC Contract.
 - iii) The applicants who are pass in (i) Qualification of Firms and (2) Financial Capabilities have to be assessed as Pre-Qualified provided that, they have obtained minimum 280 weightage points in aggregate.
 - iv) Majority of the applicants are in Joint Venture / Consortium with China based firms, who provided details in Chinese language and their English translation. It is, therefore, the authentication of the Auditors Balance Sheet (last three years attached) and proof of similar nature works is necessary as per procedure from short listed contractor prior to participate in financial bid. It may be asked to get





verification of these documents as per rule i.e. English Script got verify from Competent Office.

The above decisions of the Pre-Qualification Evaluation Committee implemented in the detailed evaluation of 13 responsive applicants. Following Contractor's Firms have been assessed as "Prequalified / Shortlisted" after detail evaluation:-
