MINUTES OF THE SEDF PROCUREMENT COMMITTEE MEETING TO OPEN BIDDING DOCUMENTS FOR HIRING OF EVENT MANAGER TO ORGANIZE LIVESTOCK, DAIRY, FISHERIES AND AGRICULTURE EXHIBITION/SEMINAR 2018 AT SINDH AGRICULTURE UNIVERSITY TANDO JAM

A meeting of SEDF Procurement Committee held on 14<sup>th</sup> December, 2017 at 1130 hrs in the Committee Room of Sindh Board of Investment, 1<sup>st</sup> Floor, Block-B, Shahrah-e-Faisal, Karachi to open bidding documents (Technical & Financial Proposals) submitted by Event Managers to organize, Livestock, Dairy, Fisheries & Agriculture Exhibition/Seminar 2018 at Sindh Agriculture University Tando Jam.

- 2. The meeting started in the name of Allah. The Finance Manager, Chairman SEDF Procurement Committee welcome the meeting participants and briefed them about the event. He give the details to Committee Members on RFP Document, Committee Members approved the RFP document. He further elaborated on the process of hiring of Event Manager for the said events as per SPP Rules 2010.
- 3. Further, he informed meeting participants that the following two Companies/Event Managers had submitted their bidding documents for organizing LDFA 2018:
  - · M/s Darbar Caterers & Decorators
  - M/s Badar Expo Solutions
- 4. Before opening the bidding documents, representative of M/s Badar Expo Solutions raise the objection that M/s Darbar Caterers & Decorators has not submitted their bidding documents as per ITB Clause 18.1 & 18.2 of RFP document. The Committee returned bidding document to M/s Darbar Caterers & Decorators without opening of document due to non-compliance of ITB Clause-18.1 & 18.2 of RFP.
- 5. The Committee evaluated the technical proposal submitted by M/s Badar Expo Solutions. The minimum qualification score needed to qualify was 70%. The Committee has evaluated and assigned the following score:
