





Meetings of Consultant Selection Committee (CSC) were held under the Chairmanship of Director General, Directorate of Urban Policy & Strategic Planning (UP&SP), Planning & Development Department, Government of Sindh on 6th and 20th August, 2018 in the committee room of the Directorate for conduct of interview / presentation and evaluation of Expression of Interest (EOIs) submitted by the interested individual consultants / experts for the assignment respectively.

2. The Secretary, Consultant Selection Committee informed the Committee that a total of two (02) individual consultants had submitted the EOIs. The EOIs were evaluated as per criteria given in EOI issued; which included 30 marks for General Qualifications (including registration with relevant professional body), 50 marks for Relevant professional experience, 10 marks for Experience in region and 10 marks for Experience with International organizations or donor agencies (a total of 100 marks). The CSC also decided to invite eligible candidates for interview and presentation. In that case, 70% weightage would be assigned on EOI and 30% weightage would be assigned to interview and presentation session.

3. As per decision by CSC, both candidates i.e. Engr. Dr. Tahir Ali Akbar and Mr. A.F Babar Sani appeared in interview and delivered their presentations on 6th August, 2018 in the CSC meeting.

4. The CSC thoroughly examined the performance of candidates who appeared in the interview session and evaluated the EOIs submitted by the interested individual consultants. Based on the evaluation of EOIs, Interviews and Presentations of the interested individual consultants, the CSC finalized the ranking of the individual consultants as below:
