





The meeting was attended by all the members of the TC.

2. The Secretary TC informed the Committee that a total number of seven (7) organizations, as mentioned below, have submitted their tender documents by the cut off time of 3 p.m. on 5th May, 2017:

- i. M/s Fine Wood Works
- ii. M/s Interwood Mobel Pvt. Ltd.
- iii. M/s New Apex Wood Works
- iv. M/s Faiz Scientific Company
- v. M/s Unique Supplies Company
- vi. M/s TK Medical Instruments
- vii. M/s Mehran Traders

3. Subsequently, the TC evaluated the technical proposals, submitted by aforementioned firms, to carry-out their scrutiny in accordance with the following parameters of eligibility criteria mentioned in NIT/ tender documents as per Rule-46 of SPP Rules, 2010 (Amended 2017):

- i. Bidder is original manufacturer of furniture items;
- ii. Bidder is registered with relevant tax authorities;
- iii. Bidder has accepted terms and conditions of tender documents;
- iv. Bidder has furnished affidavit on stamp paper for not being blacklisted; and
- v. Bidder has furnished bid security.

4. In order to ensure that the prospective firms comply with criteria (i of 3) i.e. bidders are original manufacturer of furniture items, the TC conducted visits of furniture plants/ manufacturing sites of all firms located in different regions of the country and compiled visit reports on the basis of parameters mentioned in NIT/ tender documents

5. Subsequent to this report and recommendations of TC to validate the information about bidders' ownership and registration as manufacturers with relevant tax



It was also advised to firms to furnish this information to this department by 17th August, 2017 so that tender process can be completed within extended bid validity period (copy enclosed). In response to this letter, only three firms, listed-below, furnished reply with requisite documents in order to prove their primary purpose of business and its registration with tax authorities as manufacturer:






