Load-shedding affects seat reservation at City Station

KARACHI: The reservation of railway seats at City Station, Karachi for Eid special trains and other passenger trains has been affected for three days due to excessive load-shedding, however, Pakistan Railways Karachi Division, has so far failed to arrange alternative supply, sources at City Station told media here yesterday.

They said there was electricity supply at City Station was affected, causing grave inconvenience for passengers, especially people seeking advance booking in Eid special or passenger trains.

Hundreds of people visit this railway station, and sometimes they have to return without booking as online booking process is affected due to load-shedding.

They said standby generators at City station were also not working properly. The administration has failed to make alternate arrangements to continue smooth reservation process.

They said even cold drinking water is not available for passengers. During load shedding spells passengers including women and children have to wait for their trains in darkness, which depicts a sorry picture of facilities available at railway stations of Karachi.

Divisional Commercial Officer (DCO) Pakistan Railways, Ishaq Baloch, when contacted, confirmed that electricity problem has affected the reservation process at City station. He said administration was trying hard to provide electricity through alternate generators to run the reservation process smoothly.

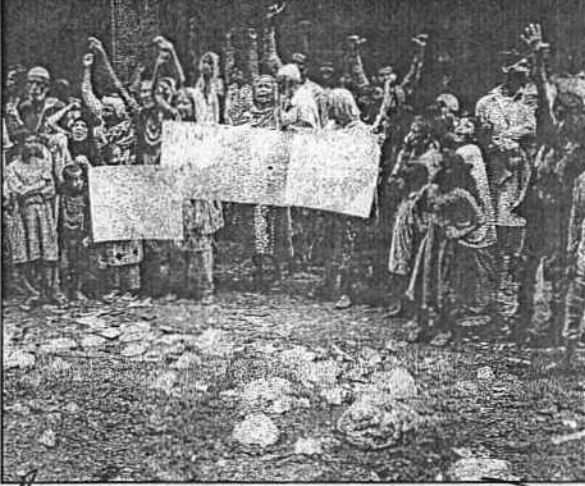
