



I am directed refer to your letter No: 3431/E&C/III-Clothing/2015-16 dated 01,12,2015 and to observed that Procuring Agency has furnished scan/photocopies of Bid Evaluation Report(s) and according to the SPPRA's policy instruction(s) conveyed vide letter dated 15,07,2014 (available on SPPRA's website), same are not hoisted. However, this Authority has further observed as under:

- i) Composition of the procurement committee for instant case was not in accordance with Rule-7 as all the members are from the Home Department and it was also not notified by the Head of Department (i.e. Secretary Home Department) hence the Procuring Agency was advised to constitute fresh procurement committee, however, the Procuring Agency failed to constitute the procurement committee according to Rule-7, which was primary requirement for a procurement.
- ii) The Procuring Agency failed to rectify the infirmity regrinding bid validity period, which was mentioned in the Bidding documents as 120-days, whereas 90-days Bid validity is allowed under Rule-38(1) of SPP Rules, 2010 (Amended 2013).
- iii) The Procuring Agency failed to provide clear and unambiguous evaluation criteria as per requirement of Rule-21(A) of SPP Rules, 2010 (Amended 2013).
- 2. In view of the above, the Procuring Agency again informed that Rule-25 & 26 is advisable in the circumstance. It may be noted that it is the sole responsibility of the Procuring Agency to ensure the compliance of SPP Rules, 2010 (Amended 2013) in letter and spirit.
