- v) Published copy of NIT in English language is required from PA in terms of Rule 17(1A)&(2) of SPP Rules, 2010 (Amended-2013) as advised earlier vide this Authority's letter dated 17.08.2015.
- vi) Copy of notification of Complaint Redressal Committee is required from PA in terms of Rule-31 of SPP Rules, 2010 (Amended-2013) as advised earlier vide this Authority's letter dated 17.08.2015.
- vii) Annual Procurement Plan is also required from PA on prescribed proforma in terms of Rule-11 of SPP Rules, 2010 (Amended-2013) as advised earlier vide this Authority's letter dated 17.08.2015.
