







Legal Information on the Specimen of the Company Profile:</p> <p>1) At serial No. 5, this firm has neither provided Amount Invested in the company nor attached attested copy of Wealth Statement for the year 2016 or 2017</p> <p>2) AT serial No. 6, Has not provided details of amount invested by each partner / share holder in the company and has also not attached wealth statements as required in the bid.</p> <p>B. Information for Employees who will be responsible for Muet project is incomplete as the CNIC numbers of employees from Sr. No. 3 to 6 are not mentioned.</p> <p>C. Company Information: Proof of property being owned by the firm is not provided.</p> <p>D. Financial Information: It is required in this section that: Annual Turnover Certificate from Bank showing greater than 25 M in last (05) years. The Bank Certificate provided by the bidder from Bank is not certifying any turnover as required in the bid. But this firm has attached un-required documents (Acknowledgment of Income Tax Returns) which are not required for ascertaining Financial Capacity.</p> <p>E. Minimum 3 Customers references were required where similar projects are installed by this firm in 2016/2017. PARCO, Customers names e.g. RSU, NAB and TPL Tracker are provided but the worth of purchase orders is not seems SIMILAR to the muet project details bellow:</p> <p>1) PARCO: The firm has supplied only 9 computers on 4 supply orders.</p> <p>2) RSU: As claimed by this firm that it has supplied 43 Desktops PCs but it has not provided copy of Purchase Order but attached "Letter of Acceptance which doesn't carry Government Ref. Number and the format of letter is not seems to be a government letter. On the other hand quantity of computers is not mentioned in the letter of acceptance.</p> <p>3) TPL Tracker: it is supplied 40 laptops on 6 supply orders.</p>	<p>Meets criteria, all documents are provided as were required in the evaluation criteria.</p> <p>All the documents are attested.</p> <p>Offered C&F Prices</p> <p>Filled C1/C2 forms.</p> <p>Delivery of goods within 6 to 8 weeks.</p> <p>It has not submitted conditional bid.</p> <p>However, following query be generated and Vendor be asked to provide affidavit regarding five years' experience of the firm as previously the same firm was doing business as M/s Ideal Distribution Line, Karachi. Now, the same firm is working with new / upgraded firm M/s Ideal Autonetec (Pvt) Ltd, Karachi and possess required experience. Vendor may be asked to submit an affidavit in this regard.</p>	<p>This firm meets most of the criteria except few. For providing fair chance of competition in the interest of University, the Deputy Director Procurement may provide opportunity to this firm and ask them to provide missing documents which are necessarily required for Technical Qualifications. The detail of missing documents is mentioned bellow:-</p> <p>1. GST Sales Tax Summaries as required in Clause 2.1</p> <p>2. Since the documents are not attested however the bidder should submit a affidavit attested by oath commissioner that the documents are copied from original and no fake or tempered document is provided in it technical proposal, and if any fake or tempered documents is found any time in future, the management of University can take any legal action against this firm including blacklisting.</p> <p>3. On ANNEXURE C1 it says that goods will be delivered within six working weeks, but on terms conditions page says goods will be delivered within 10 weeks. So get it clarified whether correct.</p>

- I. Bidder has not provided any single document as proof being **DIRECT IMPORTER. It was required at Clause 3.6 of "Technical Soundness" that the bidder must provide customs document, AWB/BL/Paid Challan as evidence of minimum five imported shipments from Principal supplier during last (05 years) This firm has submitted GST Reg certificate against the required documents, which cannot be considered.**
- J. As required in clause 3.8, The bidder has not provided any document from manufacturer which can confirm Onsite support directly to MUET.

Note:

- 1) This firm has mentioned in its Technical Proposal that it has attached all required documents, but these are not found in its profile.
- 2) It has also attached some un-required documents such as Financial Statements etc.
- 3) The terms conditions mentioned on page No. 7 seems to be conditional. On one hand it asks that the MUET should pay 100% advance LC (*University normally opened irrevocable LC not ADVANCE LC*), on the other hand it says all taxes are inclusive. But has not mentioned anything about C1 /C2

Delivery lead time required to this firm is 10 to 12 weeks.

The Deputy Director Procurement may contact this firm and ask to provide required documents. If it did not provide the required documents within seven days, then this firm would stand disqualified. If they provide required documents then they may be considered as qualified.
