M/s Pakistan Re-Insurance Company Ltd.

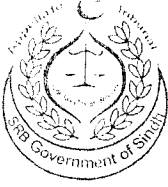

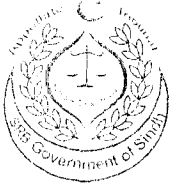
