SUBJECT: - CONSTRUCTION OF OVERHEAD BRIDGE OVER NEW NATIONAL HIGHWAY SHAH HUSSAIN BY PASS CHOWK, (3922 RFT.) (REVISED).

It is to state that the development scheme "*Construction of Flyover Bridge Over New National Highway Shah Hussain By Pass Chowk, (2300 Rft.)*" was originally approved by the PIDWP Forum vide Administrative Approval No.LG/DG/M&E/AD(MIS)18 (34-Khairpur) /13/ 1053 dated 26.5.2014 of the Local Government Department, Government of Sindh, Karachi with the cost of Rs.883.088 Million as Non-ADP Scheme during the financial year 2013-14 and the work was started. Later on the said scheme was revised by the Planning & Development Department, Government of Sindh with an additional scope and at a cost of Rs.1605.175 Million vide Administrative Approval No.LG/DG/M&E/AD(MIS)18 (27-Khairpur)/15/ 870 dated 14.4.2017 issued by the Local Government Department, Government of Sindh, Karachi.

2. The bids for the balance work and additional work were invited vide NIT No.DC/AD/P&D/2386/2017 dated 24.8.2017 in SPPRA Website. After completion of all codal formalities, the Bid Evaluation Report (BER) was hoisted on website of SPPRA on 11<sup>th</sup> October, 2017. It is to mention here that since the contract for consultancy services could not be revised and extended so far, the work order for new work could not be issued nor contract agreement has been signed by the contractor. The bid validity period of 90 days has already been passed. The contract for consultancy is likely to be extended at the earliest. It is therefore requested to extend technical and legal advise in this regard for a transparent and legal course of action.
