

- Procuring Agency has not complied of Rule-75 issuance of RFP documents, which is commencing after shortlisted Firms. Clarification is required.
- iii) Procuring Agency has opened bid on 12.09.2017 which is not mentioned in bidding documents. Clarification is required.
- iv) Procuring Agency has not furnished Certificate in light of Rule-48 of SPP Rules-2010(Amended-2017).
- v) Procuring Agency has not furnished reply of this Authority letter dated 11.05.2017, which is still awaited, however all Public Private Partnership Projects shall be processed in the light of part IV of SPP Rules-2010Amended-2010).
- 2. In view of above, it is advised to furnish requisite documents and rectify the said infirmities, at the earliest.
- 3. It may be noted that it is the sole responsibility of the procuring agency to carry all the public procurement by observing SPP Rules, 2010(Amended-2017), regulations and procedure in vogue. Non-Compliance of Sindh Public Procurement Rules, 2010 (Amended 2017) shall render the case of procurement as "Mis-procurement".
