 - iii. PA is required to furnish clippings of NIT published in English, Urdu & Sindhi languages as per Rule- 17(1A).
 - iv. PA has furnished bid data sheet but the relevant information is not included and also not as standard format, however furnish bid data sheet is required as per Rule- 21 (1) (b).
 - v. PA is required to provide evaluation criterion of subject procurement as per Rule- 21 (A).
 - vi. PA has not mentioned bid validity in NIT as well as in the bidding documents clarification required as per Rule- 38.
2. In view of above, the procuring agency is advised to intimate current status of the subject procurement and furnish above mentioned documents/clarification and take appropriate action for rectifying the infirmities, if procurement process is still valid. It may be noted that the compliance of SPP Rules 2010 (amended 2013) is the sole responsibility of procuring agency in letter and spirit.
