

The Deputy Administrator Zakat Sindh/Chairman of Procurement Committee welcomed the participants and desired to sign the attendance sheets before opening of financial bids/tenders. The Procurement Committee and the party/firm/contractor or their representatives have signed the "Attendance Sheets".

After that, In light of SPPRA Rules 2010 (amended 2013) Rule 41, the Procurement Committee opened the sealed financial bids in presence of the party/firm/contractor or their representative. The financial bids/tenders were evaluated in light of SPPRA Rules 2010 (amended 2013) Rules 46(1) i.e. "Single Stage - One Envelop", as mentioned in the Notice Inviting Tender."

OBSERVATIONS/FINDINGS OF COMMITTEE:

- Five parties / firms /supplieers viz: (1) M/s. Hawad Enterprises, (2) M/s Family & Company, (3) M/s Singer Pakistan Limited, (4) M/s W S Enterprises and (5) M/s Sindh Traders, applied for and submitted bidding documents.
- As per NIT in order to evaluate the bids/tenders, the required documents were checked and found that two parties as at sr.no.1 & 2 above have not submitted the required documents in support of their bid, therefore rejected. Besides another party as at Sr.No.5 have not filled the bidding documents, issued to them, instead of they have submitted their bid on their letter head, therefore rejected.
- M/s. Singer Pakistan Limited found eligible/responsive to bid, but rate quoted by them seems highest.

M/s. W.S Enterprises found eligible/responsive to bid and their quoted rates seems lowest then others, therefore the committee recommends for purchase of required sewing machines from them as per specification provided in the bidding documents.
