

A meeting of the Procurement Committee STEVTA was held on 22.09.2017 at 11:30 a.m. in the committee room of Sindh Technical Education & Vocational Training Authority, ST-19, Block-6, Gulshan-e-Iqbal, Karachi, to open the Bids (Technical proposals only) invited for procurement of Machinery/Equipment and Furniture/Fixture for Chinese Language Project at Sindh TEVTA Institutions. The Committee was informed that the tender notice was got published in leading newspapers; Daily Dawn (English), Daily Kawish (Sindhi) and Daily Jang (Urdu) on 30.08.2017. The same was also hoisted on website of SPPRA on 29.08.2017. According to Rule-46(2) of SPPRA Rules-2010, the Single Stage-Two Envelopes bids, containing Technical and Financial Proposals, were invited to procure the Machinery/Equipment and Furniture/Fixture for Chinese Language Project at Sindh TEVTA Institutions.

The Bid document comprises of following Two Packages containing articles required for STEVTA Institutions:

- 1) Package-I (Machinery/Equipment).
- 2) Package-II (Furniture/Fixtures).

In response to advertisement; Ten (10) interested firms purchased the bidding documents, out of which Seven (07) firms submitted their bids; containing technical & financial proposals supported with company profiles. The Technical Proposals were opened in presence of the bidders or their representatives and evaluated with regard to the qualifications requirements mentioned in the bidding document. A 'Bids Evaluation Statement' of Technical Qualifications was prepared which is attached with the minutes as **Annexure-'A'**.

On opening of Technical Proposals, Committee observed that following firms submitted their bids; for the packages mentioned against their names:

While evaluating the Technical Proposal Committee observed that the following three firms could not provide documentary evidence as required under the Technical Qualification/Criteria. The Firm wise position is given as under:

1. **M/s. SF Incorporated, Karachi:-**

- i) Firm did not fulfil the requirement of Rs.100.00 million Annual Turn over during last three years.
- ii) Firm could not provide any certificate or evidence of after sales service capability.
- iii) Affidavit of not black listed on stamp paper (in original) was not provided.
- iv) Firm remained failed to furnish copies/documentary evidence of at least 3 contracts of Rs.10.00 million each in last three years.

2. **M/s. Nazir Enterprises, Karachi:**

- i) Firm did not fulfil the requirement of Rs.100.00 million Annual Turn over during last three years.
- ii) Firm could not provide any certificate or evidence of after sales service capability.
- iii) Firm did not provide the Broachers/Drawing/Specification of quoted articles.
- iv) Firm remained failed to furnish copies/documentary evidence of at least 3 contracts of Rs.10.00 million each in last three years.

3. **M/s. A.J. Enterprises, Karachi:**

- i) Firm could not provide any certificate or evidence of after sales service capability.
- ii) Firm remained failed to furnish copies/documentary evidence of at least 3 contracts of Rs.10.00 million each in last three years.

Hénce, the committee declared the above mentioned firms Technically “Non Responsive” and decided that their Financial Proposal may be returned without opening the same.

After initial evaluation of bids, Committee decided and recommended as follows:
